AN ORDINANCE AUTHORIZING THE CITY OF MAROA TO UTILIZE TIF/ARPA FUNDS FOR THE PURPOSE OF PARTIALLY REIMBURSING RISE BROADBAND FOR COSTS RELATED TO CONSTRUCTING A CITY-WIDE BROADBAND SYSTEM.

WHEREAS the RISE Broadband is constructing a City-wide broadband system within the City of Maroa;

WHEREAS the City is authorized by law to contribute TIF and/or ARPA reimbursement funds to RISE Broadband for eligible construction costs;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:


SECTION 1. The City Council agrees to reimburse RISE Broadband the amount of **Sixty-Two Thousand, Five Hundred Dollars (\$62,500.00)** at the start of construction of the City-wide broadband system;

SECTION 2. The City Council agrees to reimburse RISE Broadband the amount of **Sixty-Two Thousand, Five Hundred Dollars (\$62,500.00)** at the completion of construction of the City-wide broadband system;




