**WHEREAS** the City entered into a waste service agreement with UWS as per Ordinance 2021/03/22-1;

**WHEREAS** UWS has subsequently been purchased by GFL;

**WHEREAS** it is in the best interests of the City to amend the existing agreement to reflect the proper entities and changes to services;


**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Maroa, Macon County, Illinois, as follows:

**SECTION 1.** The City Council authorizes the execution of the amended agreement Attached as EXHIBIT A with GFL.



**RE: Municipal Solid Waste Franchise Proposal**

Dear City Administrator Agee,

GFL Environmental is proud to present this comprehensive proposal to replace our current contract providing twice weekly trash collection in the City of Maroa. In exchange for a new five-year residential agreement, GFL will provide 95-gallon trash carts and 95-gallon recycling carts to households. Households will need to request a second trash cart or opt-in to the recycling program to participate. Each residential unit can have up to two trash carts **and** one recycling cart under this proposal. GFL will provide the City of Maroa:

- **TRASH:** Weekly trash collection for residential households in a GFL issued 95-gallon trash cart. Service locations will include alley and curbside. Weekly trash volume is limited to up to two 95-gallon carts issued by GFL. There is no volume limit on properly contained trash during the two weeks following Christmas. A private can and/or bag is limited to 35-gallons and 50-pounds. A third GFL trash cart is an additional \$3.50 per month.
- **RECYCLING:** Every-other-week curbside recycling collection in a GFL issued 95-gallon recycling cart. Recycling service will only be provided at the curb. There will be no alley recycling service. All recycling material is limited to what fits in the cart. Households must opt-in to the recycling program to participate and be issued a 95-gallon recycling cart. A second recycling cart is an additional \$3.50 per month. Recycling includes cardboard, aluminum, tin, plastics #1 and #2, newspaper and mixed paper. Glass is not included in the recycling program.
- **ANNUAL SPRING CLEANUP:** As part of the agreement, GFL will provide the City with two (2) annual free curbside community cleanups. The “bulky-item” cleanups will be limited to 5 cubic yards of material at each household. GFL cannot take hazardous waste, electronic waste, tires, or white goods during the cleanup. Cleanup dates will be agreed upon at least 30-days ahead of time by the City and GFL.
- **CITY PROPERTIES:** All City owned properties and City sponsored festivals will receive solid waste services with GFL commercial containers at no cost.



- **FREE LANDFILL DISPOSAL:** The City of Maroa will be able to deliver and dispose of up to 25-tons of municipal solid waste or demolition material annually at the Clinton Landfill at no charge. Any weight over 25-tons will be charged a \$72 per ton flat rate, no fees.

GFL will continue to collect the fee from households. The monthly fee to start the contract is **\$18.25** per unit with fixed annual 4% increases. Seniors over the age of 65 will enjoy a \$2.00 per month discount. The fee structure follows this table:

<u>Date</u>	<u>Fee</u>
December 1, 2022	\$18.25/month
December 1, 2023	\$18.98/month
December 1, 2024	\$19.74/month
December 1, 2025	\$20.53/month
December 1, 2026	\$21.35/month

The contract between GFL and the City will also contain language allowing for a two-year auto renewal period unless the City provides proper notice allowing the 5-year base contract to expire.

Under this one-time per week collection proposal, solid waste will be serviced by GFL on MONDAY in Maroa.

After the initial roll-out of 95-gallon containers, GFL will work with City staff to identify seniors and disabled residents who require the use of a smaller cart. GFL will replace their 95-gallon trash cart with a 65-gallon trash cart.
