AN ORDINANCE ESTABLISHING GUIDELINES FOR COMPENSATING AUTOMOTIVE AND HOMEOWNER'S INSURANCE DEDUCTIBLES FOR DAMAGE INCURRED BY FALLEN TREES LOCATED ON CITY RIGHTS-OF-WAY.

WHEREAS the City Council has determined that this ordinance establishing guidelines for compensating automotive and homeowner's insurance deductibles for damage incurred by fallen trees on City rights-of-way is in the best interests of the citizens of the City of Maroa, therefore,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF MAROA, MACON COUNTY, ILLINOIS AS FOLLOWS:

SECTION ONE: The City will reimburse up to Five-Hundred Dollars (\$500.00) of eligible deductible costs for damage incurred by any tree located upon City right-of-way, as long as the following requirements are met:


1. The City shall be immediately notified of any damage incurred from a tree located upon a City right-of-way.
2. Photographs of the damage and tree shall be provided to the City Clerk.
3. Proof of insurance, including a clear statement of the policy deductible shall be provided to the City Clerk.
4. A copy of the claim submitted to the insurance company shall be provided to the City Clerk.
5. The City Clerk shall submit all required information to the City Council for final approval of payment.

SECTION TWO: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


