# AN ORDINANCE ESTABLISHING GUIDELINES FOR COMPENSATING AUTOMOTIVE AND HOMEOWNER'S INSURANCE DEDUCTIBLES FOR DAMAGE INCURRED BY FALLEN TREES LOCATED ON CITY RIGHTS-OF-WAY.

WHEREAS the City Council has determined that this ordinance establishing guidelines for compensating automotive and homeowner's insurance deductibles for damage incurred by fallen trees on City rights-of-way is in the best interests of the citizens of the City of Maroa, therefore,

**NOW THEREFORE, BE IT ORDAINED** BY THE CITY COUNCIL OF MAROA, MACON COUNTY, ILLINOIS AS FOLLOWS:

**SECTION ONE:** The City will reimburse up to Five-Hundred Dollars (\$500.00) of eligible deductible costs for damage incurred by any tree located upon City right-of-way, as long as the following requirements are met:

- 1. The City shall be immediately notified of any damage incurred from a tree located upon a City right-of-way.
- 2. Photographs of the damage and tree shall be provided to the City Clerk.
- 3. Proof of insurance, including a clear statement of the policy deductible shall be provided to the City Clerk.
- 4. A copy of the claim submitted to the insurance company shall be provided to the City Clerk.
- 5. The City Clerk shall submit all required information to the City Council for final approval of payment.

**SECTION TWO:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication is pamphlet form as provided by law.
